The quarter ended 30 June 2018 was a profitable one. Net income before taxation was \$2,163,759 which was 8.2% less than the corresponding period in 2017. Sales increased by 8.8% and gross margin by 3.5%. Expenses were \$9,274,986 which was 6.8% more than 2017. This was due to increases in employment costs and selling expenses, and were mostly related to the increase in sales. A dividend payment of \$\$2,713,358 was made in April 2018, and was financed by a short term loan. There were no major capital expenditure. Additions to fixed assets were for the replacement of assets worn- out in the normal course of business. The financial strength of the company remains strong with a current ratio of 1:1.56 and a debt to equity ratio of 0.258:1

Results for the three months ended 30 June 2018 were satisfactory. Net income before taxation was \$2,163,759 which was 8.2% below 2017. The group is liquid as it continues to generate positive cash flows for working capital needs; at 30 June 2018 the current ratio was 1:1.56.

Loans installments and interest were paid as they fell due. There were no defaults.

An interim dividend will be paid later in the year. No major capital projects are planned for the remainder of the financial year.

There were no capital commitments.

Results for the nine months ended 30 June 2018 were satisfactory. Net income before taxation was \$10,265,034 which was 3.3% below 2017.

Group sales of \$121,033,390 was an increase of 9.25% over 2017.

Management is not aware of any events that would materially affect the profitability of the group other than the rate of the country's economic growth. Outlook for the rest of the year is for the same level of profitability as 2016/17.
