General Discussion and Analysis of Financial Condition

The three months ended 31 December 2015 was an outstanding quarter mainly due to sales for December which increased by 26% over 2014; this resulted in income before tax of \$6,017,9763, an increase of 29.13% over the preceding year's quarter.

The group is in a sound financial position with a Debt (loans & overdraft) to equity ratio of 0.287:1 and a current ratio of 1:1.22. The group is liquid with adequate working capital and is well able to pay its debts as and when they fall due. There were no material changes in these ratios than at 30 September 2015.

Earnings per share for the quarter were \$0.13 compared to \$0.10 for 2014. Management expects the remaining three quarters to be profitable as well.

Discussion of Liquidity and Capital Resources

At the end of the financial year, 30 September 2015, there were no capital commitments. During the quarter ended 30 December 2015, the group converted \$3,000,000 of its overdrafts to a term loan at a lower rate of interest. Loans principal and interest were paid on their due dates; there were no defaults. Economic trends are favourable and the group expects another profitable year in 2016.

Overview of Results of Operations

The just ended quarter was the most profitable quarter ever for the group, primarily due to sales activity in December, which increased by 26% over December 2014.

Sales for the quarter increased by 8.71%, over the similar period in 2014, to \$49,014,286 and gross revenue by 16.65% to \$2,230,561. Expenses increased by 10.0% mainly in selling expenses and in wages - due to normal normal wage increases and also increase in staffing levels. Net income before tax increased by 29.13% to \$6,017,973.

The group continues to benefit from its solar plant. All profit centers returned a profit for the period. The outlook for the remainder of the financial year is for the profitability trend to continue,
