#### **QUESTIONS**

#### 1. Business

There were no business developments for the year 2016.

#### 2. Properties

The company currently owns two (2) parcels of land. They are as follows:

Section: Road/Sandy Ground

Block: 08513B Parcel: 205 Acreage: 2

Section: South Central

Block: 38511B Parcel: 28 Acreage: 36.7

Richard's Architecture valued the property/land of NICA on 17 July 2016 to ascertain the fair value. Property. Land recorded a value of EC\$7,897,500 as at 31 December 2015, a decrease of EC\$769,500.00, as compared to a value of EC\$8,667,000 in 2014.

Management entered into a lease rental agreement with the Anguilla Aluminum commencing 1 February 2015, for a period of 5 years, for the rental of the Sandy Ground Building. The lease will yield a monthly rental income of US\$2,500.00.

The proposed plan to develop the property at Gibbons Estate to house a Nursing University is awaiting funding. The directors approached several banks for funds, but we unsuccessful in acquiring a loan owing to the company's inability to generate cash flows to meet the loan obligations.

#### 3. Legal Proceedings

There were no legal proceedings brought before the company during the year 2016.

#### 4. Submission of Matters to a Vote of Security Holders

The company held its Annual General Meeting on 19 October 2016. Owing to a lack of a quorum the meeting was rescheduled for 8 November 2016..

The audited accounts for the years 2014 and 2015 were presented to the shareholder. The shareholder expressed that they had waited too long to receive a dividend. The directors presented several option to

the shareholder as it relate the determination of the company. The options included the sale of the shares over the counter, the buy-out of the company by interested companies and the dissolution of the company. The shareholder were of the view that the sale or dissolution of the company would leave shareholder with no value. The shareholders unanimously agreed that the company should remain until the economy is becomes economically viable.

The directors further discussed that the plans to develop a Nursing Schools was brought to the Minister of Health, who advised that the Ministry is working on the Nursing Legislation. It was highlighted that the enacting of the Nursing Legislation would enable consultants to be engaged in the writing of a business plan, which will be presented to investors.

Shareholder present indicated their willingness to provide the required capital to conduct the market research and business plan of the project. The directors indicated that the commencement of the project is high dependent on the enacting of the Nursing Legislation.

There were no sale of equity securities during the year 2016.

# 10. Management's Discussion and Analysis of Financial Condition and Results of Operation

The company recorded a loss of EC\$1,137,813.00 during the year 2015, accounting for 81% increase in losses as compared to 2014. This was due to the decrease in the value of land/property amounting to EC\$769,500 and the decline in investment value amounting to EC\$402,00.00 (NBA Shares). These investment write-downs were consistent to the global decline in economic activity. It must be noted however, that revenues amounting to EC\$74,250.00 during the year 2015 from the rental of the Sandy Ground building were adequate to offset operating expenses of EC\$59,236.00. Comparatively, at the end of December 2014, the company was unable to record revenues, owing to the non-rental of the building at Sandy Ground.

The company continues to receive dividend income from the Eastern Caribbean Home Mortgage Bank (ECHMB), Anguilla Electricity Company Limited (Anglec) and Cable & Wireless (CW). During the year 2014 and 2015 the company recorded dividend income amounting to EC\$23,432.00 and EC\$18,431.00 respectively. ECHMB accounted for EC\$15,000.00 of dividend income in 2015 as compared to EC\$20,000 in 2014, while Anglec accounted for EC\$3,360 over the same periods.

The value for available-for-sale securities as at 31 December 2015 is EC\$507,420.00 as compared to EC\$955,554.00 as the end of December 2014, showing a decline in value of EC\$402,00.00. The auditors felt that it was prudent to write down the shares of the National Bank of Anguilla based on the announcement to discontinue operations and form a bridge bank, the decision to transfer approximately EC2.8 million dollars in good assets and matching liabilities and the appointment of a receiver. This write down in assets has contributed significantly to the loss position as at 31 December 2015. Other security investments held with Anguilla National Insurance Company Limited and Anguilla Electricity Company Limited remained stable. Investment held with Cable & Wireless Communications PLC increased in value by EC\$16,866.00 and is expected to increase based on market trends.

The company's share capital remained stable as the majority shareholders are still optimistic that with the access to capital, the development of the land at Gibbon's Estate and Sandy Ground and the establishment of sound business strategies, the company can experience a turnaround. However shareholder equity has declined by 12% as at the end of 2015. This is due primarily to the loss position of the company during the year 2015.

Short-term liabilities remained fairly stable during 2015 as compared to 2014. This consisted of audit and accounting fees for the year 31 December 2015. These fees are usually settled over a sixty day period.

The directors continue to liaison with Medical Experts to determine the possibility of developing Gibbons Estate. Management has determined that the following are critical to the progression of plans:

1. The enacting of the Nursing Legislation in the House of Assembly

- 2. Obtaining capital to commence research and the preparation of a business plan
- 3. The selection of an investor to invest in the Nursing University

The directors proposed the following options after receiving requests from shareholders who indicated that they were desirous of liquidating the company:

- i. Continue with minimal operations;
- ii. Voluntary wind-up;
- iii. Sale of company shares over the counter by those wishing to do so;
- iv. Outright sale of Company to investors willing to buy out all shareholders; and
- v. Sale of a majority of the equity and surrender to control an investor or investor group

The majority shareholders are of the view that the company should remain until the economy is returned to a stable state.

# 11. Changes in and Disagreements With Auditors on Accounting and Financial Disclosures

The company did not change its auditors and there were no disclosure disagreements with auditors.

#### 12. Directors and Executive Officers of the Reporting Issuer:

<u>Vida Lloyd-Richardson</u>: Mrs. Vida Lloyd-Richardson is a passed employee of Cuisinart Hotel. She holds qualifications in Human Resource Management and worked within the capacity as Human Resource Manager. Mrs. Lloyd-Richardson brings years of human resource experience to the board. Mrs. Lloyd-Richardson runs her own restaurant business. Mrs. Richardson officially resigned from the board on 21 October, 2016 due to her busy schedule.

Anne Edwards: Ms. Anne Edwards is a passed teacher at the Albena Lake-Hodge Comprehensive School. She was employed with the Government as Deputy Principal of the Secondary School. She holds a bachelors degree in General Studies and a Master's degree in Management of Secondary Schools. Ms. Edwards brings to the board her experience in curriculum management.

<u>Calvert Carty:</u> Mr. Carty holds a degree in Business Administration from the University of the Virgin Islands. He was the owner and manager of Last Flight Restaurant and servers as a director on the Anguilla Development Board. Mr. Carty brings to us his managerial skills.

<u>Clara Richardson:</u> Ms. Richardson holds a degree in accounting. She has worked within the capacity as accountant in the Treasury Department of the Government of Anguilla. Ms. Richardson brings to us her accounting skills. Ms. Richardson officially resigned from the board on 19 October, 2016.

<u>Caryl Connor:</u> Mr. Connor has worked within the capacity as accountant at Cap Juluca Hotel. He is currently retired and runs his own construction business.

<u>Seymour Hodge:</u> Mr. Seymour Hodge holds a bachelors degree in Economics/ Political Science and a Master's degree in Urban Affairs. He has worked within the capacity as adjunct lecturer at the Borough of Manhattan Community College, New York, Sales/distribution manager at New Day,
