# General Discussion and Analysis of Financial Condition

Grenreal saw a 5.15% increase in income at the end of the first quarter in 2025 (2025: \$1,611,670, 2024: \$1,532,792). In comparison to the first quarter in 2024, Grenreal leased kiosks to new tenants as well as commenced charging tenants for parking in the tenants' parking area. Grenada celebrated its 51<sup>st</sup> independence, therefore there was a weeklong of activities and this meant an increase in business in the malls. Generally, in terms of through-put, there was an increase seen during the first quarter of 2025 in comparison to 2024.

In terms of total operating and general expenses, there was a 5.24% increase at the end of the first quarter in 2025 (2025: \$718,541, 2024: \$682,757). The company tries its best to manage the increasing costs in a way the company can remain sustainable. Net profit for the quarter increased by 32.02% over the previous year (2025: \$530,680, 2024: \$401,958).

The combined vacancy rate in both malls is 0.39%. Units that become vacant are leased in no time, after the necessary checks are done. Inquiries are constantly coming in for space which continue to show the malls as a place of relevance.

#### Discussion of Liquidity and Capital Resources

The working capital at the end of the first quarter in 2025 was 1.40:1 as compared to 2024 which was 1.25:1, December 2024 1.42:1. The increase in the ratio over 2025 is due to the increase in the cash balance despite the decrease in the receivables and prepayment balance, as well as, the decrease in current liabilities. Management continues to ensure tenants adhere to their obligations to pay rent on a timely manner and adhere to payment plans those who are on one. As the ratio shows, the company is in a position and deals with short-term obligations as they fall due.

The company also continues to service its long-term obligations, that is, the syndicate bond and the moratorium interest loan. This is evident with the decrease in the debt-to-equity ratio, 2025: 0.54:1 and 2024 0.58:1.

There was a 0.33% decrease in non-current assets. This is mainly due to the fair value loss on the property that the company recognized at the end of 2024, -0.66%. Computers and office furniture however had a 59.50% increase due to the purchasing of fixed asset items such as new AC units, a

Income increased by 5.15% at the end of the first quarter of 2025 in comparison to the same quarter in 2024. The rate for tenants on the second floor of the Bruce Street Mall increased by \$0.50 from January 2025. Also, the malls welcomed new kiosks during the quarter. Revenues from the car park as well as the public washroom also saw increases, due to the increase in traffic to the malls.

Operating expense increased by 7.13% due to the increase in insurance expense as the rate for the period 2025 to 2026 increased. Utilities also increased due to the commissioning of the new AC units in the Esplanade Mall area. Training cost was incurred during the period, also, the increase in transportation expense is due to transportation provided for staff on Sundays and public holidays. General expense decreased by 6.62% due to the decrease in the banking fees and the decrease in directors' fee.

Finance charge decreased by 19.11%.

# 1) Nature of the real estate industry: A place of the real estate industry:

There are existing shopping malls in Grenada that can be viewed as competitors of Grenreal. In terms of pricing they can have lower rates. However, Grenreal as the sole cruise passenger mall on the island retains a competitive edge.

# 2) Dependency on economic conditions:

Limited economic activities has an adverse effect on revenue collection. This was evident during the covid 19 pandemic.

# 3) Development of the tourism industry:

A vibrant tourism industry would positively affect on Grenzeal's business. The Grenada Tourism Authority aggressively markets destination Grenada. The result of an increase in cruise arrivals and stay over visitors brings increased throughput to the malls.

# 4) Liquidity risk:

Grenreal can face difficulty in meeting its financial obligations in particular loan payments. The company as far as possible continues to mitigate same by ensuring sufficient resources are available when due, under both stressed and normal conditions. As part of receivables management tenants are actively engaged to comply with lease terms and conditions and granted discounts where necessary.
